Petitions for nomination must contain the signatures of at least 1% of the total credit union membership and be accompanied by a certificate from the nominee stating that they accept the nomination and agree to serve.

If there are no other nominees, Jamie Gomes, Vasantha Esvara and Karen McDougal are expected to be re-elected to the Board of Directors for a three-year term by acclamation at the Annual Meeting in February 2026.




